REMEMBER: To be submitted to the Returning Officer on or before 2:00 p.m. on the day fixed for close of nominations.

CHECKLIST FOR THE SUBMISSION OF THE NOMINATION PAPER

FILING DEADLINE

- Form E-405, Candidate's Nomination Paper, must be personally submitted to the Returning Officer no later than 2:00 p.m. on the day fixed for close of nominations.

NOMINATION DEPOSIT

- \$100 deposit must be submitted to Returning Officer at same time as form E-405, Candidate's Nomination Paper. The deposit must be:
- in Canadian currency;
 - either a **postal money order or a certified cheque** drawn on a valid account in a chartered bank, trust company or credit union; and
 - made payable to the Saskatchewan Minister of Finance.

THE RETURNING OFFICER CANNOT ACCEPT CASH
Nomination Papers submitted with a cash deposit will be rejected.

CANDIDATE WITH A POLITICAL AFFILIATION

A Candidate may choose to file the Nomination Paper with either:

- Form E-517, Declaration of a Candidate's Political Affiliation; **or**
- Form E-517C, Declaration of Candidate's Political Affiliation Composite

Either of these forms must be signed by the Leader of the registered political party, or a designated representative, in order for the candidate's political affiliation to appear on the ballot.

A Candidate that is not endorsed by a registered political party or who has not completed Form E-517(C) will have the word "INDEPENDENT" appear below his or her name.

ELECTRONIC FILING

In the case of an emergency, a Returning Officer may accept a Nomination Paper by facsimile.

The candidacy will only be valid if the originals and the required \$100 deposit are subsequently provided to the Returning Officer within 48 hours of the filing deadline.
