

# NOVEMBER 13 IS BY-ELECTION DAY

## FOR THE CONSTITUENCY OF LLOYDMINSTER



#### WHAT DO I BRING?

You need to bring your identification (ID). To vote, you must prove your identity and address. There are more than 50 acceptable ID options. See the back of this brochure for a list of acceptable ID, or visit **elections.sk.ca/identification**.

#### WHAT TIME DO I VOTE?

OR

Remember your time zones on by-election day. Mountain Time is one hour earlier than Central Time. Voting hours on November 13 are: 9 a.m. to 8 p.m. Central Time (8 a.m. to 7 p.m. Mountain Time).

#### WHERE TO VOTE?

Each voter has a specific voting place. There are 17 in total for this by-election. For the list, and to see where you vote, visit **elections.sk.ca/wheretovote**, call **306.825.6462**, toll free **1-844-533-0079** or email **RO17A@elections.sk.ca**.

#### TO VOTE, YOU MUST PROVE YOUR IDENTITY AND ADDRESS

OR

### **OPTION 1**

Show one piece of identification with your photo, name and physical address. The address cannot be a post office box number. It must be issued by a government agency.

EXAMPLE: Driver's licence



Show two valid original documents. Both pieces must have your name and one must also have your address.

EXAMPLE: Health card, utility bill



### **OPTION 3**

Swear an oath and have an eligible voter vouch for your identity and place of ordinary residence. The person vouching for you must have valid authorized identification (both of you will be required to make a sworn statement). This person can only vouch for one person.

EXAMPLE:

A neighbour, your roommate.

## **AUTHORIZED IDENTIFICATION**

#### VALID ORIGINAL IDENTIFICATION DOCUMENTS

- Birth Certificate
- Canadian Blood Services Donor Card
- Canadian Passport
- Certificate of Canadian Citizenship (Citizenship Card) issued by Citizenship and Immigration Canada
- Canadian National Institute for the Blind (CNIB) client card bearing the individual's photograph and signature or a card bearing the individual's photograph and signature issued by any registered charitable organization that provides services to persons with disabilities
- Credit Card issued by a bank or credit union
- Debit Card issued by a bank or credit union
- Identification issued by the Canada Border Services Agency
- Identification issued by Canadian Air Transportation Security Agency (CATSA)
- Identity Card issued by the Canadian Forces
- Employee Card issued by the Government of Canada, the Government of Saskatchewan, a Saskatchewan municipality, a school division or an Indian band in Saskatchewan, or an agency of one of these entities
- Firearm Possession and Acquisition Licence or Possession Only Licence issued pursuant to The Firearms Act
- Fishing, Trapping or Hunting Licence issued pursuant to The Fisheries (Saskatchewan) Act, 1994 or The Wildlife Act
- Hospital bracelet
- Métis Nation Status Card issued by the Métis Nation Saskatchewan
- Old Age Security Card issued pursuant to the Old Age Security Act
- Pleasure Craft Operators Licence issued pursuant to the Canada Shipping Act
- Parole Card
- Passport of a Foreign State
- Radio Operator Card or Certificate issued by Industry Canada

- Saskatchewan Driver's Licence issued pursuant to The Traffic Safety Act
- Saskatchewan Health Services Card issued pursuant to The Department of Health Act
- Social Insurance Number Card issued by the Government of Canada
- Student Identification Card issued by a post-secondary institution regulated by a Saskatchewan Act
- Union Identification Card
- Veterans Affairs Canada Health Identification Card
- Voter information card issued by the chief electoral officer
- Wildlife Habitat Certificate
- Any other piece of identification issued by the Government of Canada, the Government of Saskatchewan, a Saskatchewan municipality, a school division or an Indian band in Saskatchewan, or an agency of one of these entities bearing the individual's name

#### ORIGINAL DOCUMENTS (WITH NAME AND ADDRESS)

- Admission Form that is in a form acceptable to the Chief Electoral Officer and that is issued by the authority responsible for a shelter, soup kitchen, student or seniors residence or a facility designated as a health centre pursuant to The Facilities Designation Regulations that provides long-term care
- Attestation of Residence that is in a form acceptable to the Chief Electoral Officer and that is issued by the authority responsible for a student or seniors residence or a facility designated as a health centre pursuant to The Facilities Designation Regulations that provides long-term care
- Bank Card Statement issued by a bank or credit union
- Blank cheque bearing the individual's name and address
- Bill issued by Saskatchewan Power Corporation, SaskEnergy, Saskatchewan Telecommunications or a municipality

- Credit Card Statement issued by a bank or credit union
- Certificate of Title issued by Information Services Corporation
- Certificate of vehicle registration issued pursuant to The Traffic Safety Act
- Correspondence issued by a post-secondary institution regulated by a Saskatchewan Act
- Document issued or certified by a court in Canada
- Government Cheque or Cheque Stub issued by the Government of Canada, the Government of Saskatchewan, a Saskatchewan municipality, a school division or an Indian band in Saskatchewan, or an agency of one of these entities
- Income Tax Assessment Notice issued by the Canada Revenue Agency
- Insurance Policy
- Letter from the Public Guardian and Trustee
- •Letter of Authorization from a First Nations band
- Letter of stay that is in a form acceptable to the Chief Electoral Officer and that is issued by the authority responsible for a shelter, soup kitchen or a facility designated as a health centre pursuant to The Facilities Designation Regulations that provides long-term care
- Pay cheque or receipt issued by an employer
- Pension Plan Statement of Benefits, Contributions or Participation
- Property Tax Assessment Notice or a Tax Notice issued by a municipality
- Residential Lease or Mortgage Statement
- Statement of Government Benefits (employment insurance, old age security, social assistance, disability support or child tax benefit) issued by the Government of Canada or the Government of Saskatchewan
- Statement of Crop Insurance issued by the Saskatchewan Crop Insurance Corporation
- Statement issued by the Workers' Compensation Board
- Voter identification card issued by a Saskatchewan municipality that shows name and address
