A U D I T O R ' S R E P O R T

To: Gladys Johnston, Business Manager of Deb Higgins,
Candidate in the election in the constituency of
Moose Jaw - Wakamow.

I have audited the return of election expenses of Deb Higgins, Candidate in the election in the constituency of the Moose Jaw - Wakamow, for the campaign period from July 9, 2007 - January 14, 2008. This return is the responsibility of the business manager. My responsibility is to express an opinion on the return based on my audit.

Except as explained in the following paragraph, I conducted my audit in accordance with generally accepted auditing standards. Those standards require that I plan and perform an audit to obtain reasonable assurance whether the return is free of material evidence supporting the amounts and disclosures in the return. An audit also includes assessing the accounting principles used and significant estimates made by the business manager, as well as evaluating the overall return presentation.

Due to the nature of the types of transactions inherent in any election campaign, it is impracticable through auditing procedures to determine that the accounting records include all transactions for the campaign period. Accordingly, my verification of these transactions was limited to the amounts recorded in the accounting records of the business manager and candidate and I was not able to determine whether any adjustments might be necessary to those expenses.

In my opinion, except for the effect of adjustments, if any, which I might have determined to be necessary had I been able to satisfy myself as to the completeness of the records as described to the preceding paragraph, the return presents fairly, in all material respects, the financial transactions of the candidate's campaign required by section 261 of The Election Act, 1996, to be detailed in the return of election expenses for the campaign period from July 9, 2007 to January 14, 2008.

I further report that contributions received by the campaign, total \$16,155.00 and expenses total \$46,620.02.


