**AUDITOR'S REPORT**

To: **Brad Hoffmann, Business Manager of Eileen Gelowitz, Saskatchewan Party Candidate, Saskatoon Fairview.**


I have audited the return of election expenses of Eileen for the campaign period from October 10, 2007 to November 7, 2007. This return is the responsibility of the business manager. My responsibility is to express an opinion on the return based on my audit.

Except as explained in the following paragraph, I conducted my audit in accordance with generally accepted auditing standards. Those standards require that I plan and perform an audit to obtain reasonable assurance whether the return is free of material misstatement. An audit includes examining, on a test basis, evidence supporting the amounts and disclosures in return. An audit also includes assessing the accounting principles used and significant estimates made by the business manager as well as evaluating the overall return presentation.

Due to the nature of the types of transactions inherent in any election campaign, it is impracticable through auditing procedures to determine that the accounting records include all transactions for the campaign period. Accordingly, my verification of these transactions was limited to the amounts recorded in the accounting records of the business manager and candidate and I was not able to determine whether any adjustments might be necessary to those expenses.

In my opinion, except for the effect of adjustments, if any, which I might have determined to be necessary had I been able to satisfy myself as to the completeness of the records as described in the preceding paragraph, the return presents fairly, in all material respects, the financial transactions of the candidate's campaign required by section 261 of *The Election Act*, 1996 to be detailed in the return of election expenses for the campaign period from October 10, 2007 to November 7, 2007.

A "**Schedule of Adjustments**" is attached which lists changes I determined to be necessary, clarification of certain items and comments on certain items.

**Eileen Gelowitz: Schedule of Adjustments November 7, 2007 Election  
(Saskatchewan Party Candidate - Saskatoon Fairview)**

1. The Contributions page 3 is \$1,476.68 lower than the amount on page 5. This is the exact amount of unpaid Invoice number 1748 to the Saskatchewan Party for printing and distribution. There has to be further documentation to both validate the donation and related election expenses claim on page 16 as *Advertising*. It would appear this is not an *Advertising* expense but rather *Services*.
2. *Petty Expenses* contain expenses outside the writ period (item #9) and likely ineligible expenses (item #7). There was no claim for bank charges which are \$20.00 per month plus one NSF fee.
3. *Hire of Premises* has no claim since there was no actual campaign office location.
4. It was stated that \$700.00 of the Saskatoon Fastprint invoice under *Goods Supplied* was paid in cash. This has not been independently verified by this audit.
5. Some cancelled cheques were unavailable at time of audit since they had not been received from the bank.

The value of donations in kind must be recorded and included as a contribution received by the business manager where claimed as an election expense. Accordingly, commercial value is an election expense and a contribution concurrently.
