#### **AUDITOR'S REPORT**

To: Brad Hoffmann, Business Manager of Eileen Gelowitz, Saskatchewan Party Candidate, Saskatoon Fairview.

I have audited the return of election expenses of Eileen for the campaign period from October 10, 2007 to November 7, 2007. This return is the responsibility of the business manager. My responsibility is to express an opinion on the return based on my audit.

Except as explained in the following paragraph, I conducted my audit in accordance with generally accepted auditing standards. Those standards require that I plan and perform an audit to obtain reasonable assurance whether the return is free of material misstatement. An audit includes examining, on a test basis, evidence supporting the amounts and disclosures in return. An audit also includes assessing the accounting principles used and significant estimates made by the business manager as well as evaluating the overall return presentation.

Due to the nature of the types of transactions inherent in any election campaign, it is impracticable through auditing procedures to determine that the accounting records include all transactions for the campaign period. Accordingly, my verification of these transactions was limited to the amounts recorded in the accounting records of the business manager and candidate and I was not able to determine whether any adjustments might be necessary to those expenses.

In my opinion, except for the effect of adjustments, if any, which I might have determined to be necessary had I been able to satisfy myself as to the completeness of the records as described in the preceding paragraph, the return presents fairly, in all material respects, the financial transactions of the candidate's campaign required by section 261 of *The Election Act, 1996* to be detailed in the return of election expenses for the campaign period from October 10, 2007 to November 7, 2007.

A "Schedule of Adjustments" is attached which lists changes I determined to be necessary, clarification of certain items and comments on certain items.

#### Eileen Gelowitz: Schedule of Adjustments November 7, 2007 Election (Saskatchewan Party Candidate - Saskatoon Fairview)

- 1. The Contributions page 3 is \$1,476.68 lower than the amount on page 5. This is the exact amount of unpaid Invoice number 1748 to the Saskatchewan Party for printing and distribution. There has to be further documentation to both validate the donation and related election expenses claim on page 16 as *Advertising*. It would appear this is not an *Advertising* expense but rather *Services*.
- 2. Petty Expenses contain expenses outside the writ period (item #9) and likely ineligible expenses (item #7). There was no claim for bank charges which are \$20.00 per month plus one NSF fee.
- 3. Hire of Premises has no claim since there was no actual campaign office location.
- 4. It was stated that \$700.00 of the Saskatoon Fastprint invoice under *Goods Supplied* was paid in cash. This has not been independently verified by this audit.
- 5. Some cancelled cheques were unavailable at time of audit since they had not been received from the bank.

1. This Return must be transmitted to the Returning Officer within three (3) months after Election Day.

2. This Return must be accompanied by the auditor's report to the business manager of the candidate on the information given in this Return.

#### Subsection 261(1)

3. The commercial value of goods and services donated (other than volunteer labour or goods valued at \$200.00 or less), and the difference between the amount paid and the commercial value of goods and services provided, are considered to be election expenses. If the total of "commercial value" is greater than the total of "amount paid" it is the larger of the two figures that is used in the calculation of election expenses incurred by the candidate. See definition of "commercial value", subsection 220(c).

4. A statement, signed and receipted, by the donor and by the business manager, supported by a verification from an independent commercial source of the amount expensed must be submitted when making claim of commercial value as an election expense.

5. All payments of more than \$25.00 must be accompanied by a supplier document that states the particulars of the election expense and by a receipt or cancelled cheque that provides proof of payment. The supplier documents and proofs of payment must be submitted with this Return.

Further, if the candidate dies or withdraws before appointing a business manager, the candidate's estate or the candidate shall pay the excess amount in accordance with the above.

A true and correct copy, certified by the business manager, for each such statement of contribution received pursuant to subsections 240(6) and (7), must be affixed to this Return (ss. 261(3)).

Revenue received by a candidate from fund-raising activities, meetings and sales of material of a promotional nature are deemed contributions. The total net proceeds from each source indicated must be recorded and, in the aggregate, reported in this Return.

The value of donations in kind must be recorded and included as a contribution received by the business manager where claimed as an election expense. Accordingly, commercial value is an election expense and a contribution concurrently.
