### **AUDITOR'S REPORT**

To: William F. (Bill) Ryan, Business Manager of Don Johannesson, Saskatchewan Party Candidate, Saskatoon Nutana.

I have audited the return of election expenses of Don Johannesson for the campaign period from October 10, 2007 to November 7, 2007. This return is the responsibility of the business manager. My responsibility is to express an opinion on the return based on my audit.

Except as explained in the following paragraph, I conducted my audit in accordance with generally accepted auditing standards. Those standards require that I plan and perform an audit to obtain reasonable assurance whether the return is free of material misstatement. An audit includes examining, on a test basis, evidence supporting the amounts and disclosures in return. An audit also includes assessing the accounting principles used and significant estimates made by the business manager as well as evaluating the overall return presentation.

Due to the nature of the types of transactions inherent in any election campaign, it is impracticable through auditing procedures to determine that the accounting records include all transactions for the campaign period. Accordingly, my verification of these transactions was limited to the amounts recorded in the accounting records of the business manager and candidate and I was not able to determine whether any adjustments might be necessary to those expenses.

In my opinion, except for the effect of adjustments, if any, which I might have determined to be necessary had I been able to satisfy myself as to the completeness of the records as described in the preceding paragraph, the return presents fairly, in all material respects, the financial transactions of the candidate's campaign required by section 261 of *The Election Act, 1996* to be detailed in the return of election expenses for the campaign period from October 10, 2007 to November 7, 2007.

A "Schedule of Adjustments" is attached which lists changes I determined to be necessary, clarification of certain items and comments on certain items.

# Don Johannesson: Schedule of Adjustments November 7, 2007 Election (Saskatchewan Party Candidate - Saskatoon Nutana)

- 1. There was no claim for expected interest expense as per loan agreement.
- 2. The bank service charges were \$160.00 to the end of December, 2007 and cost of cheque printing was \$123.96. There was no claim made for neither amount.
- 3. The *Donor's Statement* for *Hire of Premises* has minimal documentation as to how commercial market value was determined.
- 4. There was an amount of \$10,000.00 claimed as advertising to the Saskatchewan Party Fund Inc. when the invoice indicates \$8,000.00 was advertising and \$2,000.00 was for polling.
- 5. No signed Joint Agreements were available where applicable.
- 6. It appears that some portion of *Goods Supplied* claim with respect to purchases from Equity Capital One were outside the writ period. However, a purchase for just the writ period would have been unlikely due to minimum purchase requirements (4 weeks).
- 7. The payment to Acadia Petro Canada for \$423.28 had insufficient documentation to explain the exact nature of the expense.
- 8. There is a capital cost portion in the payment to OTV Technologies for \$1,336.95 since it included the cost of a new computer.
- 9. A donation-in-kind from Le Petit Gourmet was not claimed as an eligible election expense even though it was included as part of contributions on page 8 of the Candidate's Return of Election Expenses.
- 10. Proofs of payments (i.e. cancelled cheques) were not available for payments made in January, 2008.

- 3. The commercial value of goods and services donated (other than volunteer labour or goods valued at \$200.00 or less), and the difference between the amount paid and the commercial value of goods and services provided, are considered to be election expenses. If the total of "commercial value" is greater than the total of "amount paid" it is the larger of the two figures that is used in the calculation of election expenses incurred by the candidate. - 4. A statement, signed and receipted, by the donor and by the business manager, supported by a verification from an independent commercial source of the amount expensed must be submitted when making claim of commercial value as an election expense.

The sum of the categories should reflect the total contributions received for the use of the candidate in each classification schedule.

A true and correct copy, certified by the business manager, for each such statement of contribution received pursuant to subsections 240(6) and (7), must be affixed to this Return (ss. 261(3)).

Revenue received by a candidate from fund-raising activities, meetings and sales of material of a promotional nature are deemed contributions. The total net proceeds from each source indicated must be recorded and, in the aggregate, reported in this Return.

The value of donations in kind must be recorded and included as a contribution received by the business manager where claimed as an election expense. Accordingly, commercial value is an election expense and a contribution concurrently.
