**INDEPENDENT AUDITORS' REPORT**

**Report on the Financial Information**

We have audited the accompanying financial information of David Sawkiw, which is comprised of Schedule E-412 Candidate's Return of Election Expenses, Schedule E-413 Declaration of a Business Manager of a Candidate and E-414 Candidate's Declaration as to Expenses for the period ending April 3, 2016. These Schedules and Declarations have been prepared by the Candidate David Sawkiw and his Business Manager Neil Fenske based on the financial reporting provisions of Section 250 of the Elections Act, 1996 and guidelines issued by the Chief Electoral Officer.

**Candidate's Responsibility for the Schedules**

The candidate is responsible for the preparation and fair presentation of this financial information in accordance with the financial reporting provisions of Section 250 of the Elections Act, 1996 and guidelines issued by the Chief Electoral Officer, and for such internal control as the Chief Electoral Officer determines is necessary to enable the preparation of financial information that is free from material misstatement, whether due to fraud or error.

**Responsibility**

Our responsibility is to express an opinion on the Schedules based on our audit. We conducted our audit in accordance with Canadian generally accepted auditing standards. Those standards require that we comply with ethical requirements and plan and perform the audit to obtain reasonable assurance about whether the Schedules and Declarations are free from material misstatement.

An audit involves performing procedures to obtain audit evidence about the amounts and disclosures in the Schedules. The procedures selected depend on the auditors' judgment, including the assessment of the risks of material misstatement of the Schedules and Declarations, whether due to fraud or error. In making those risk assessments, the auditor considers internal control relevant to the entity's preparation and fair presentation of the Schedules and Declarations in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the entity's internal control. An audit also includes evaluating the appropriateness of accounting policies used and the reasonableness of accounting estimates made by management, as well as evaluating the overall presentation of the Schedules and Declarations.

We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our qualified audit opinion.

**Basis for Qualified Opinion**

Due to the inherent nature of the transactions of organizations of this type, the completeness of the various categories of income and expenses is not susceptible to satisfactory audit verification. Accordingly, verification of these revenues and expenses was limited to the amounts recorded in the records of David Sawkiw. Therefore, we were not able to determine whether any adjustments might be necessary to income and expenses.

**Qualified Opinion**

In our opinion, except for the effects of the matter described in the Basis for Qualified Opinion paragraph, Schedules and Declarations E-412, E-413 and E-414 are prepared, in all material respects, in accordance with the financial reporting provisions of Section 250 of the Elections Act, 1996 and guidelines issued by the Chief Electoral Officer.

The value of donations in kind must be recorded and included as a contribution received by the business manager where claimed as an election expense. Accordingly, commercial value is an election expense and a contribution concurrently.


