Report on the Financial Information

We have audited the accompanying financial information of Frank Serfas, which is comprised of Schedule E-412 Candidate's Return of Election Expenses for the period ending April 3, 2016. This Schedule has been prepared by the Candidate Frank Serfas and his Business Manager John Koban based on the financial reporting provisions of Section 250 of the Elections Act, 1996 and guidelines issued by the Chief Electoral Officer.

Candidate's Responsibility for the Schedules

The candidate is responsible for the preparation and fair presentation of this financial information in accordance with the financial reporting provisions of Section 250 of the Elections Act, 1996 and guidelines issued by the Chief Electoral Officer, and for such internal control as the Chief Electoral Officer determines is necessary to enable the preparation of financial information that is free from material misstatement, whether due to fraud or error.

Responsibility

Our responsibility is to express an opinion on the Schedule based on our audit. We conducted our audit in accordance with Canadian generally accepted auditing standards. Those standards require that we comply with ethical requirements and plan and perform the audit to obtain reasonable assurance about whether the Schedule are free from material misstatement.

An audit involves performing procedures to obtain audit evidence about the amounts and disclosures in the Schedule. The procedures selected depend on the auditors' judgment, including the assessment of the risks of material misstatement of the Schedule, whether due to fraud or error. In making those risk assessments, the auditor considers internal control relevant to the entity's preparation and fair presentation of the Schedule in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the entity's internal control. An audit also includes evaluating the appropriateness of accounting policies used and the reasonableness of accounting estimates made by management, as well as evaluating the overall presentation of the Schedule.

We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our qualified audit opinion.

Basis for Qualified Opinion

Due to the inherent nature of the transactions of organizations of this type, the completeness of the various categories of income and expenses is not susceptible to satisfactory audit verification. Accordingly, verification of these revenues and expenses was limited to the amounts recorded in the records of Frank Serfas. Therefore, we were not able to determine whether any adjustments might be necessary to income and expenses.

Qualified Opinion

In our opinion, except for the effects of the matter described in the Basis for Qualified Opinion paragraph, Schedule E-412 is prepared, in all material respects, in accordance with the financial reporting provisions of Section 250 of the Elections Act, 1996 and guidelines issued by the Chief Electoral Officer.
