To the Business Manager for Justin Stranack Green Party Candidate Last Mountain - Touchwood Candidate:

I have audited the return of election expenses of the Committee to Elect Justin Stranack for the campaign period from March 8 to April 4, 2016. This return is the responsibility of the business manager. My responsibility is to express an opinion on the return based on my audit.

Except as explained in the following paragraphs, I conducted my audit in accordance with Canadian generally accepted auditing standards. Those standards require that I plan and perform an audit to obtain reasonable assurance whether the return is free of material misstatement. An audit includes examination, on a test basis, evidence supporting the amounts and disclosures in the return. An audit also includes assessing the accounting principles used and significant estimates made by business manager, as well as evaluating the overall return presentation.

Due to the nature of the types of transactions inherent in any election campaign, it is impracticable through auditing procedures to determine that the accounting records include all transactions for the campaign period. Accordingly my verification of these transactions was limited to the amounts recorded in the accounting records of the business manager and candidate and I was not able to determine whether any adjustments might be necessary to those expenses.

Section 240(6) of The Election Act 1996 requires contributions from a corporation, trust fund or constituency association to be accompanied by a statement which sets out the name of and the amount contributed by, each person who contributed in excess of \$250 in a year and whose contribution was used to make up the contribution from the corporation, constituency association or trust fund. The statement must identify the person authorized to make the contribution and must be certified by the business manager, that the information on the statement was true and correct.


The return includes a cash contribution from the Green Party of Saskatchewan of \$50. The information in the return is correct based on the signed copy of the bank statement and the Statement of Contribution Registered Party.

The expenditure on Part II (a) Candidate Campaign Expenses to the amount of \$93.24 was for a private vehicle expense. There are only kilometers given but there are no signed statements to verify the amount of the vehicle usage.

There is a \$1 service fee included in the return on Part II (e) Services. This amount is from the \$50 contribution from an unincorporated organization or association. There is a bank statement to verify the amount.

The return includes an expenditure of \$52.73 on Part II (f) Goods Supplied. This amount is for paper used to make flyers. This amount is verified with a till receipt on March 19th, 2016.

In my opinion, except for the effect of adjustments, if any, which I have determined to be necessary had I been able to satisfy myself as to the completeness of the records as described in the preceding paragraphs, the return presents fairly, in all material respects, the financial transactions the candidate's campaign required by Section 261 of The Election Act, 1996 to be detailed in the return of election expenses for the campaign period March 8 to April 4, 2016.


