To the Business Manager for Eric Schalm Green Party Candidate Meadow Lake Candidate:

I have audited the return of election expenses of the Committee to Elect Eric Schalm for the campaign period from March 8 to April 4, 2016. This return is the responsibility of the business manager. My responsibility is to express an opinion on the return based on my audit.

Except as explained in the following paragraphs, I conducted my audit in accordance with Canadian generally accepted auditing standards. Those standards require that I plan and perform an audit to obtain reasonable assurance whether the return is free of material misstatement. An audit includes examination, on a test basis, evidence supporting the amounts and disclosures in the return. An audit also includes assessing the accounting principles used and significant estimates made by business manager, as well as evaluating the overall return presentation.

Due to the nature of the types of transactions inherent in any election campaign, it is impracticable through auditing procedures to determine that the accounting records include all transactions for the campaign period. Accordingly my verification of these transactions was limited to the amounts recorded in the accounting records of the business manager and candidate and I was not able to determine whether any adjustments might be necessary to those expenses.

Section 240(6) of The Election Act 1996 requires contributions from a corporation, trust fund or constituency association to be accompanied by a statement which sets out the name of and the amount contributed by, each person who contributed in excess of \$250 in a year and whose contribution was used to make up the contribution from the corporation, constituency association or trust fund. The statement must identify the person authorized to make the contribution and must be certified by the business manager, that the information on the statement was true and correct.

The return includes donations in kind by three individuals totaling \$1,670.38. There are only statements to verify \$1,600 of this amount.

The expenditure on Part II (a) Candidate Campaign Expenses to the amount of \$63.00 was for a private vehicle expense. The amount of kilometers given agrees to the amount on the Travel Claim form totaling 590 km at a rate of \$0.42 per kilometer, less \$187.80 of the amount from personal account and this amount is verified through the Statement of Personal Expenses Paid by a Candidate form.

On Part II (e) Services, the expenditure of \$593.22 is for mailing flyers and bank fees. There is a vendor invoice for the amount of \$591.22 to verify the amount for mailing flyers.

Part II (f) Goods Supplied is for an expenditure totaling \$951.16. This amount is for making signs and printing flyers. Both expenses include a vendor invoice from Prairie Graphics.

In my opinion, except for the effect of adjustments, if any, which I have determined to be necessary had I been able to satisfy myself as to the completeness of the records as described in the preceding paragraphs, the return presents fairly, in all material respects, the financial transactions the candidate's campaign required by Section 261 of The Election Act, 1996 to be detailed in the return of election expenses for the campaign period March 8 to April 4, 2016.

The value of donations in kind must be recorded and included as a contribution received by the business manager where claimed as an election expense. Accordingly, commercial value is an election expense and a contribution concurrently.
