

To the Business Manager for Larry Neufeld Green Party Candidate Regina Lakeview Candidate:

I have audited the return of election expenses of the Committee to Elect Larry Neufeld for the campaign period from March 8 to April 4, 2016. This return is the responsibility of the business manager. My responsibility is to express an opinion on the return based on my audit.

Except as explained in the following paragraphs, I conducted my audit in accordance with Canadian generally accepted auditing standards. Those standards require that I plan and perform an audit to obtain reasonable assurance whether the return is free of material misstatement. An audit includes examination, on a test basis, evidence supporting the amounts and disclosures in the return. An audit also includes assessing the accounting principles used and significant estimates made by business manager, as well as evaluating the overall return presentation.

Due to the nature of the types of transactions inherent in any election campaign, it is impracticable through auditing procedures to determine that the accounting records include all transactions for the campaign period. Accordingly my verification of these transactions was limited to the amounts recorded in the accounting records of the business manager and candidate and I was not able to determine whether any adjustments might be necessary to those expenses.

Section 240(6) of The Election Act 1996 requires contributions from a corporation, trust fund or constituency association to be accompanied by a statement which sets out the name of and the amount contributed by, each person who contributed in excess of \$250 in a year and whose contribution was used to make up the contribution from the corporation, constituency association or trust fund. The statement must identify the person authorized to make the contribution and must be certified by the business manager, that the information on the statement was true and correct.

There are a total of 19 contributions. Contributions amounting to \$788.11 through 15 contributions are from individuals. There is one corporate contribution of \$200.00 and one contribution from an Unincorporated Organizations or Associations totaling \$342.88. Lastly, there are two contributions from Other Persons or Groups of Persons totaling \$768.70. One of the contributions is from tickets sold at a karaoke fundraiser and the remaining amounts are from the collections made at that event. Altogether, it amounts to \$2,099.69 in contributions.

The return includes an expenditure of \$17.66 on Part II (d) Advertising for promotional reasons through Facebook for the period of February 9<sup>th</sup>, 2016 to February 14<sup>th</sup>, 2016. There are no invoices to verify the amounts.


On Part (e) Services, the candidate expensed an amount of \$300.00 for processes a charge through the Scotiabank bank account.

An expense of \$1,862.07 for Part (f) Goods Supplied was expensed to the candidate account. The expenses entail flyer and printing handouts from Rayacom Regina and Microprint Inc. The amounts agree to the statements and invoices from Rayacom Regina and Microprint Inc.

The total expenditure for this candidate are \$2,179.73.

There are missing bank statements and information. The only statements available to us were only up to February 2016 meaning any invoices dated in March 2016 are not included in the bank statements. Contributions of \$2,074.54 were included in the bank statements but the total contributions equal \$2,099.69 causing a difference of \$25.15 or 1.2%.

In my opinion, except for the effect of adjustments, if any, which I have determined to be necessary had I been able to satisfy myself as to the completeness of the records as described in the preceding paragraphs, the return presents fairly, in all material respects, the financial transactions the candidate's campaign required by Section 261 of The Election Act, 1996 to be detailed in the return of election expenses for the campaign period March 8 to April 4, 2016.

The value of donations in kind must be recorded and included as a contribution received by the business manager where claimed as an election expense. Accordingly, commercial value is an election expense and a contribution concurrently.
