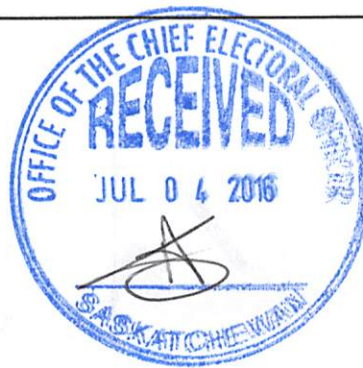

To the Business Manager for Billy Patterson Green Party Candidate Regina Rochdale Candidate:

I have audited the return of election expenses of the Committee to Elect Billy Patterson for the campaign period from March 8 to April 4, 2016. This return is the responsibility of the business manager. My responsibility is to express an opinion on the return based on my audit.

Except as explained in the following paragraphs, I conducted my audit in accordance with Canadian generally accepted auditing standards. Those standards require that I plan and perform an audit to obtain reasonable assurance whether the return is free of material misstatement. An audit includes examination, on a test basis, evidence supporting the amounts and disclosures in the return. An audit also includes assessing the accounting principles used and significant estimates made by business manager, as well as evaluating the overall return presentation.


Due to the nature of the types of transactions inherent in any election campaign, it is impracticable through auditing procedures to determine that the accounting records include all transactions for the campaign period. Accordingly my verification of these transactions was limited to the amounts recorded in the accounting records of the business manager and candidate and I was not able to determine whether any adjustments might be necessary to those expenses.

Section 240(6) of The Election Act 1996 requires contributions from a corporation, trust fund or constituency association to be accompanied by a statement which sets out the name of and the amount contributed by, each person who contributed in excess of \$250 in a year and whose contribution was used to make up the contribution from the corporation, constituency association or trust fund. The statement must identify the person authorized to make the contribution and must be certified by the business manager, that the information on the statement was true and correct.

The return includes a contribution by an individual of \$28.98. There are no statements to verify the amount.

The expenditure on Part II (a) Candidate Campaign Expenses to the amount of \$28.98 was for a travel expenses with a private vehicle. These expenses were paid by donation in kind by the candidate and there is no bank statement to verify the amount.

In my opinion, except for the effect of adjustments, if any, which I have determined to be necessary had I been able to satisfy myself as to the completeness of the records as described in the preceding paragraphs, the return presents fairly, in all material respects, the financial transactions the candidate's campaign required by Section 261 of The Election Act, 1996 to be detailed in the return of election expenses for the campaign period March 8 to April 4, 2016.

The value of donations in kind must be recorded and included as a contribution received by the business manager where claimed as an election expense. Accordingly, commercial value is an election expense and a contribution concurrently.





and I further solemnly declare that I will not, except so far as I may be permitted by law, at any future time make or be party to the making or giving of any payment, reward, office, employment or valuable consideration for the purpose of defraying any such expenses as last mentioned, or provide or be party to the providing of any money, security or equivalent for the purpose of defraying any such expenses;

and I make this solemn declaration conscientiously believing it to be true, and knowing that it is of the same force and effect as if made under oath, and by virtue of the **Canada Evidence Act**.
