To the Business Manager for Shawn Setyo Green Party Candidate Saskatoon Eastview Candidate:

I have audited the return of election expenses of the Committee to Elect Shawn Setyo for the campaign period from March 8 to April 4, 2016. This return is the responsibility of the business manager. My responsibility is to express an opinion on the return based on my audit.

Except as explained in the following paragraphs, I conducted my audit in accordance with Canadian generally accepted auditing standards. Those standards require that I plan and perform an audit to obtain reasonable assurance whether the return is free of material misstatement. An audit includes examination, on a test basis, evidence supporting the amounts and disclosures in the return. An audit also includes assessing the accounting principles used and significant estimates made by business manager, as well as evaluating the overall return presentation.

Due to the nature of the types of transactions inherent in any election campaign, it is impracticable through auditing procedures to determine that the accounting records include all transactions for the campaign period. Accordingly my verification of these transactions was limited to the amounts recorded in the accounting records of the business manager and candidate and I was not able to determine whether any adjustments might be necessary to those expenses.

Section 240(6) of The Election Act 1996 requires contributions from a corporation, trust fund or constituency association to be accompanied by a statement which sets out the name of and the amount contributed by, each person who contributed in excess of \$250 in a year and whose contribution was used to make up the contribution from the corporation, constituency association or trust fund. The statement must identify the person authorized to make the contribution and must be certified by the business manager, that the information on the statement was true and correct.

The return includes cash contributions by individuals totaling \$601.00. This amount excludes the amount for expenses. There is also a \$20.00 contribution for a meeting for an informal fundraising birthday party. There are bank statements to verify both these amount.


The expenditure on Part II (a) Candidate Campaign Expenses to the amount of \$21.00 was for a private vehicle expense. The Travel Claim form shows 200 km

but 150 km was deemed personal mileage. This amount is verified through the Statement of Personal Expenses Paid by a Candidate form.



The value of donations in kind must be recorded and included as a contribution received by the business manager where claimed as an election expense. Accordingly, commercial value is an election expense and a contribution concurrently.
