



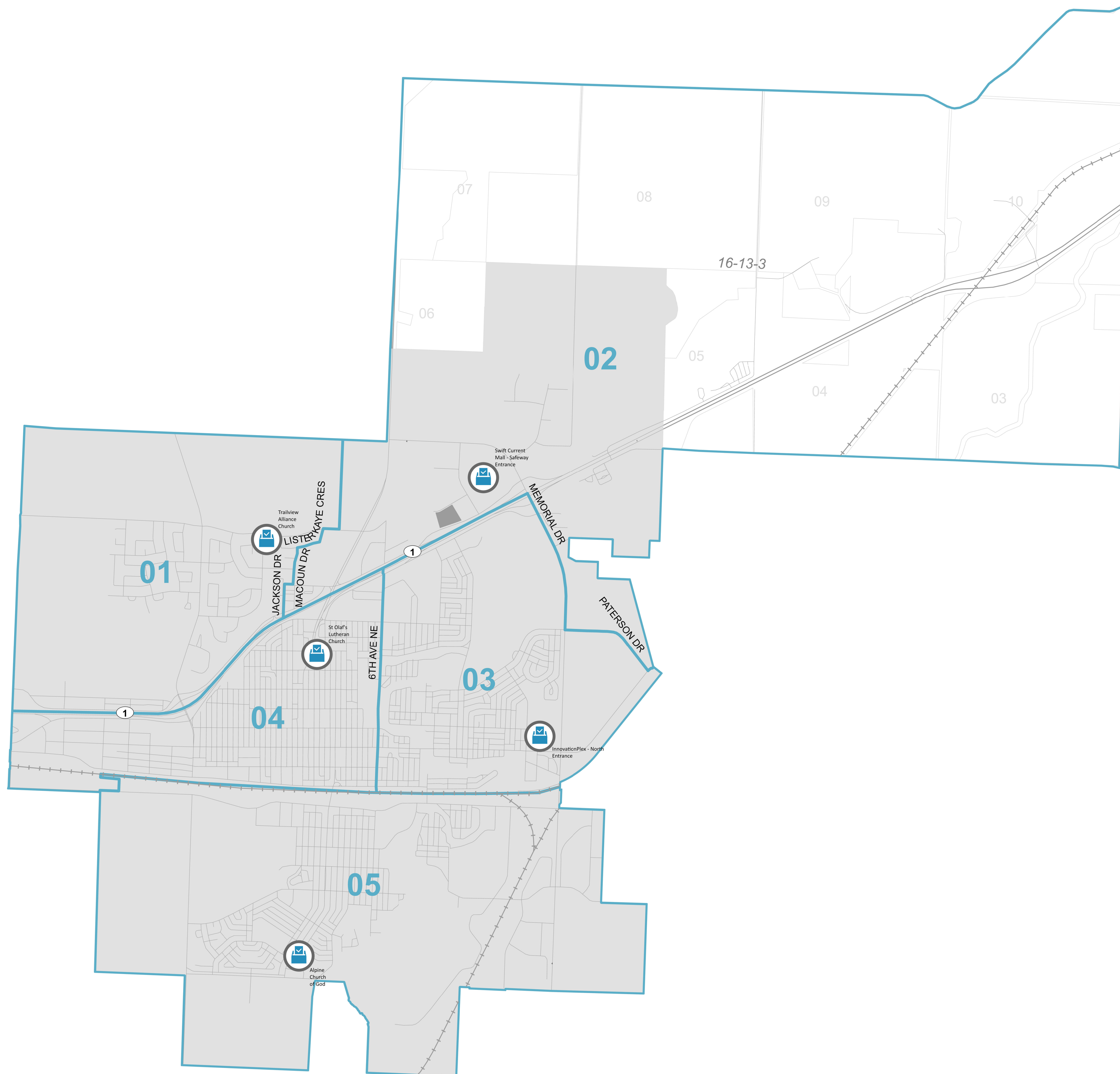
Proclamation of the Returning Officer Declaring the Time and Place for the Nomination of Candidates and the Day of Opening the Polling Places

# Proclamation

## Constituency of SWIFT CURRENT

His Majesty's Writ bearing the date October 1st, 2024, having been directed to me, public notice is now given:

1. That I am commanded to cause an election, to be held according to law, of a member to serve in the Legislative Assembly of Saskatchewan for the above-mentioned constituency.
2. That I will, on October 12th, 2024, from 9:00 a.m. until 2:00 p.m. attend at 197 4th Avenue Northwest, Swift Current, to receive nominations.
3. That in case voting of voters is required, polling places will be open from October 22nd to October 26th, 2024 from 10:00 a.m. to 7:00 p.m. and on October 28, 2024, from 9:00 a.m. until 8:00 p.m.



4a. All eligible voters may vote at any of the following voting locations between **October 22nd to October 26th, 2024, from 10:00 a.m. to 7:00 p.m., unless otherwise stated:**

- Alpine Church of God, 925 2nd Avenue Southeast, Swift Current
- InnovationPlex - North Entrance, 2001 Chaplin Street East, Swift Current
- St Olaf's Lutheran Church, 665 Central Avenue North, Swift Current
- Swift Current Mall - Safeway Entrance, 1 Springs Drive, Swift Current
- Trailview Alliance Church, 298 Battleford Trail, Swift Current

4b. All eligible voters must vote at the voting location assigned to the polling division area they reside within, on **October 28, 2024, from 9:00 a.m. until 8:00 p.m., unless otherwise stated.**

- Area: 01 Trailview Alliance Church 298 Battleford Trail, Swift Current
- Area: 02 Swift Current Mall - Safeway Entrance 1 Springs Drive, Swift Current
- Area: 03 InnovationPlex - North Entrance 2001 Chaplin Street East, Swift Current
- Area: 04 St Olaf's Lutheran Church 665 Central Avenue North, Swift Current
- Area: 05 Alpine Church of God 925 2nd Avenue Southeast, Swift Current

5. That licensed Personal Care Facility voting locations will be established at the following locations during the following times:

- Cypress House Ltd., 2135 Scott Street, Swift Current (October 22nd: 9:00 a.m. to 1:00 p.m.)
- The Meadows, 2215 Woodrow Lloyd Place, Swift Current (October 23rd: 9:00 a.m. to 1:00 p.m.)
- Willow Creek Manor by iCare, 700 Aberdeen Street, Swift Current (October 24th: 9:00 a.m. to 12:00 p.m.)

6. That Hospital and Remand Centre voting locations will be established at the following locations during the following times:

- Clover House, 2215 Woodrow Lloyd Place, Swift Current (October 28th: 9:00 a.m. to 12:00 p.m.)
- Cypress Regional Hospital, 2004 Saskatchewan Drive, Swift Current (October 28th: 9:00 a.m. to 1:00 p.m.)

7. That at 200 Lakeshore Drive, Regina, on the 9th day of November, 2024, at the hour of 9:00 a.m., the ballot boxes and, in the case of a general election, the ballot envelopes containing the ballots of voters at hospitals and remand centres shall be opened and counted and, where there are voters who voted by mail and displaced voters, open the ballot envelopes containing the ballots of those voters and count those ballots and make the addition of the votes given for each candidate and declare elected the candidate having the largest number of votes.

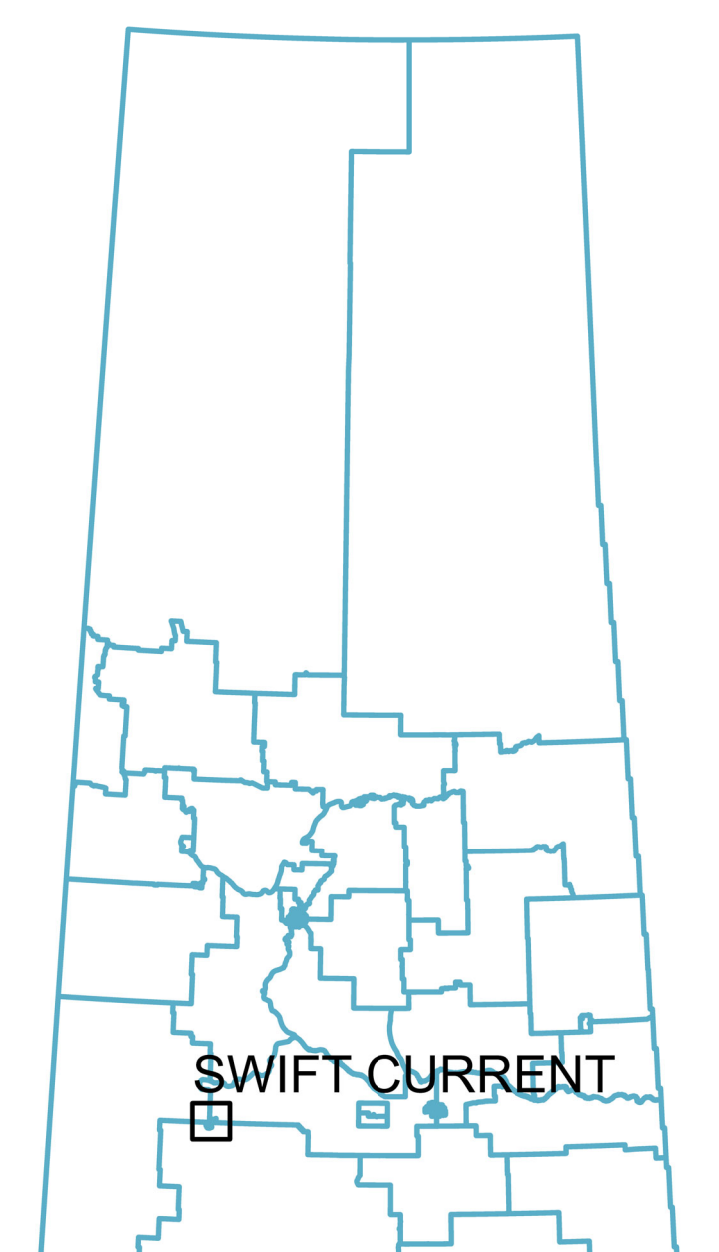
All persons are required to take notice and to govern themselves accordingly.

### Warning

189(1) No person shall unlawfully take down, cover up, mutilate, deface or alter an election proclamation, notice or other document required to be posted pursuant to this Act. Any person violating the provision of subsection 189(1) is guilty of an offence and, subject to subsection 216(2) of this Act, if convicted, is liable to a fine of not more than \$5,000.00 or to imprisonment for a term not exceeding two years or to both.
