






## Constituency of WHITE CITY-QU'APPELLE


His Majesty's Writ bearing the date October 1st, 2024, having been directed to me, public notice is now given:

- 1. That I am commanded to cause an election, to be held according to law, of a member to serve in the Legislative Assembly of Saskatchewan for the above-mentioned constituency.
- 2. That I will, on October 12th, 2024, from 9:00 a.m. until 2:00 p.m. attend at 194 Bay Avenue, Fort Qu'Appelle, to receive nominations.
- 3. That in case voting of voters is required, polling places will be open October 22nd to October 26th, 2024 from 10:00 a.m. to 7:00 p.m. and on October 28, 2024, from 9:00 a.m. until 8:00 p.m.
