## Constituency of ATHABASCA

Her Majesty's Writ bearing the date January 18th, 2022, having been directed to me, public notice is now given:

- 1. That I am commanded to cause an election, to be held according to law, of a member to serve in the Legislative Assembly of Saskatchewan for the above-mentioned constituency.
- 2. That I will, on January 29th, 2022, from 9:00 a.m. until 2:00 p.m. attend at Lot 9 Block C (Lavoie Street and Smith Avenue), Beauval, to receive nominations.
- 3. That in case voting of voters is required, polling places will be open on February 15th, 2022, from 9:00 a.m. until 8:00 p.m. as follows:










First Nations Reserve Chicken 224 Inset Polling Divisions 03 to 04






Northern Town of La Loche Inset Polling Divisions 05 to 10

- Green Lake Community Hall, 315 North Street, Green Lake Minahik Gas Bar (Lower Level), L41 BLK3 Hill Top Avenue, Pinehouse Lake ICSI Radio Station (Board Room), Lajeunesse Ave, Parcel K, Île-à-la-Crosse
- Saturday February 12th, 2022 12:00 noon to 8:00 p.m. Sunday February 13th, 2022 12:00 noon to 8:00 p.m.
- 5. Personal Care Facility polling places will be established on February 9th to February 13th, 2022. Please go to www.elections.sk.ca for locations and times.
- 6. That Hospital and Remand Centre Polls will be established on February 15th, 2022. Please go to www.elections.sk.ca for locations and times.
- 7. That at Lot 9 Block C (Lavoie Street and Smith Avenue), Beauval, on February 28th, 2022 at 9:00 a.m., I shall open the ballot boxes and, in the case of a general election, I shall open the ballot envelopes containing the ballots of voters at hospitals and remand centres, count those ballots and, where there are absentee voters and displaced voters, open the ballot envelopes containing the ballots of those voters and count those ballots and make the addition of the votes given for each candidate and declare elected the candidate having the largest number of votes.

All persons are required to take notice and to govern themselves accordingly. All times in this proclamation are Central Standard Time. God Save the Queen. Given under my hand at Beauval, Saskatchewan, January 18th, 2022.
