Dear Mr. Speaker:

On October 16, 2023, I submitted a series of CEO Directives to the Board of Internal Economy for its consideration. On November 29, 2023, I received an email from the Government House Leader indicating that he would like to see a revised version of CEO Directive 2023-010 Polling Period with voting hours on the last day of voting of 9 a.m. to 8 p.m. The enclosed document, saved as version 2.0 or (v2.0) includes that change – with voting on the first five days taking place from 10 a.m. to 7 p.m. as proposed in the previous Directive, but from 9 a.m. to 8 p.m. on the last day. I understand that the Board will consider this version alongside the original one (which had the hours of voting on all days being from 10 a.m. to 7 p.m.).

As the Board enters into discussion, I want to be clear about the important reasoning behind selecting the hours as originally proposed (10 a.m. to 7 p.m. on all days). First, having consistent voting hours is important for electors as they become accustomed to the new Voting Week approach. Based on legislation and agreement among political parties, we are moving away from having "advance voting" and "election day voting" (these will no longer exist) to a "voting week" during which electors will have a total of 54 hours of voting, already 3 more hours than in 2020. All of Elections Saskatchewan's public messaging would emphasize consistency across the six days of voting. Changing the hours on the last day of voting from the first five days of voting will create confusion for voters.

Second, and more importantly, following the decision to eliminate vote counting equipment from the suite of technology to be used, the operational team at Elections Saskatchewan spent weeks determining how an increased number of ballots placed in manual ballot boxes (due to an increased number of voters being served by electronic poll books) can be counted within the time allotted for counting once voting locations close. A key solution to this challenge has been to close voting locations at 7 p.m. as opposed to 8 p.m. I am very concerned that, if vote counting does not begin until 8 p.m., results will not be received until very late and, in some instances, the count may need to be delayed until the next day. This would have a serious impact on how the public perceives election results. With this understanding in hand, I would ask that the Board approve the CEO Directive put forward on October 16 which had consistent voting hours of 10 a.m. to 7 p.m. on all days of voting.
