## NOTICE:

Where any information filed in the Register of the Chief Electoral Office pursuant to The Election Act, 1996 (s. 224 and s. 289) is altered, the chief official agent of the registered political party or the leader of the registered political party shall, within 30 days, notify the Chief Electoral Officer in writing (this form) of the alteration and any subsequent replacements thereof (s.226(1)). Upon receipt of any such notice, the Chief Electoral Officer shall vary the register accordingly (s. 226(4)).

If you are confirming party details for an election period or designating representatives for an election period use Form E-515.
