#### INDEPENDENT AUDITOR'S REPORT

To Jeremy Rondeau Business Manager The Swift Current By-election Everett Hindley

Report on the Return

We have audited the accompanying Candidate's Return of Election Expenses (the "return") for the candidacy of Everett Hindley, a candidate in the by-election of a member to serve in the Legislative Assembly of Saskatchewan held on the 1<sup>st</sup> day of March 2018. The Return is comprised of Summary of Contributions and Expenses, Part I - Details of Contributions, Part II - Details of Expenses, Declaration of a Business Manager of a Candidate and Candidate's Declaration as to Expenses. This return is the responsibility of the business manager. Our responsibility is to express an opinion on the return based on our audit.

Business Manager's Responsibility for the Return of Election Expenses

The Business Manager is responsible for the preparation of the election return in accordance with the financial reporting provisions of The Elections Act, 1996 and for such internal control as the financial agent determines is necessary to enable the preparation of election financing reports that are free from material misstatement, whether due to fraud or error.

Auditor's Responsibility

Our responsibility is to express an opinion on the election return based on our audit. We conducted our audit in accordance with Canadian generally accepted auditing standards as required by Section 261 of The Election Act, 1996 (Saskatchewan). Those standards require that we comply with ethical requirements and plan and perform the audit to obtain reasonable assurance about whether the election expense return is free from material misstatement.

An audit involves performing procedures to obtain audit evidence about the amounts and disclosures in the election expense return. The procedures selected depend on the auditor's judgment, including the assessment of risks of material misstatement of the election expense return; wither due to error or fraud. In making those risk assessments, the auditor considers internal control relevant to the Business Manager's preparation of the election expense return in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the internal control. An audit also includes evaluating the appropriateness of accounting policies used and reasonableness of accounting estimates made by the Business Manager, as well as evaluating the overall presentation of the election expense return.

We believe that the audit evidence obtained is sufficient and appropriate to provide a basis for by qualified audit opinion.

**Basis for Qualified Opinion** 

Due to the nature of the transactions inherent in any election campaign, the completeness of contributions and other revenue and expenses is not susceptible to satisfactory audit verification. Accordingly, our verification of these transactions was limited to the amounts recorded in the accounting records of the business manager and candidate and we were not able to determine whether any adjustments might be necessary to those expenses.

**Qualified Opinion** 

In our opinion, except for the effects of the matter described in the Basis for Qualified Opinion paragraph, the return presents fairly, in all material respects, the financial transactions of the candidate's campaign required by Section 261 of The Election Act, 1996 to be detailed in the return of election expenses for the campaign period from February 2, 2018 to March 1, 2018.

#### Designation of Reimbursement (Section 269 and 270)

#### a) Candidates Endorsed by a Registered Political Party

If eligible for reimbursement, the Candidate directs the Minister of Finance to pay any reimbursement to (check one):

Chief Official Agent of the Registered Political Party

Business Manager of the Candidate

If the value of all contributions and any reimbursement received exceeds the election expenses incurred by or on behalf of the candidate, the candidate's business manager shall pay the excess amount to the chief official agent of the registered political party or the candidate's constituency association, as directed by the candidate.

#### b) Candidates Not Endorsed by a Registered Political Party

If the value of all contributions received exceeds the election expenses incurred by or on behalf of the candidate, the Minister of Finance shall pay no reimbursement.

If the value of all contributions received does not exceed the election expenses but the value of those contributions and the reimbursement calculated exceeds the election expenses incurred by or on behalf of the candidate, the Minister of Finance shall pay to the business manager an amount equal to the election expenses less the contributions received.

If the value of all contributions and any reimbursement received exceeds the election expenses incurred by or on behalf of the candidate, the candidate's business manager shall pay the excess amount to the **Minister** of Finance.

#### Death or Withdrawal of Candidate (Section 271)

If the candidate dies or withdraws from an election and prior to the death or withdrawal, the value of all contributions to the candidate exceeds the candidate's election expenses, the candidate's business manager shall:

- a) where the candidate was endorsed by a registered political party, pay the excess amount to the chief official agent of the registered political party.
- **b)** where the candidate was not endorsed by a registered political party, pay the excess amount to the Minister of Finance.

Further, if the candidate dies or withdraws before appointing a business manager, the candidate's estate or the candidate shall pay the excess amount in accordance with the above.

Contributions include money provided to or on behalf of the candidate without compensation from the candidate and includes donations in kind.

Revenue received by a candidate from fund-raising activities, meetings and sales of material of a promotional nature are deemed contributions. The total net proceeds from each source indicated must be recorded and, in the aggregate, reported in this Return.

The value of donations in kind must be recorded and included as a contribution received by the business manager where claimed as an election expense. Accordingly, commercial value is an election expense and a contribution concurrently.
