

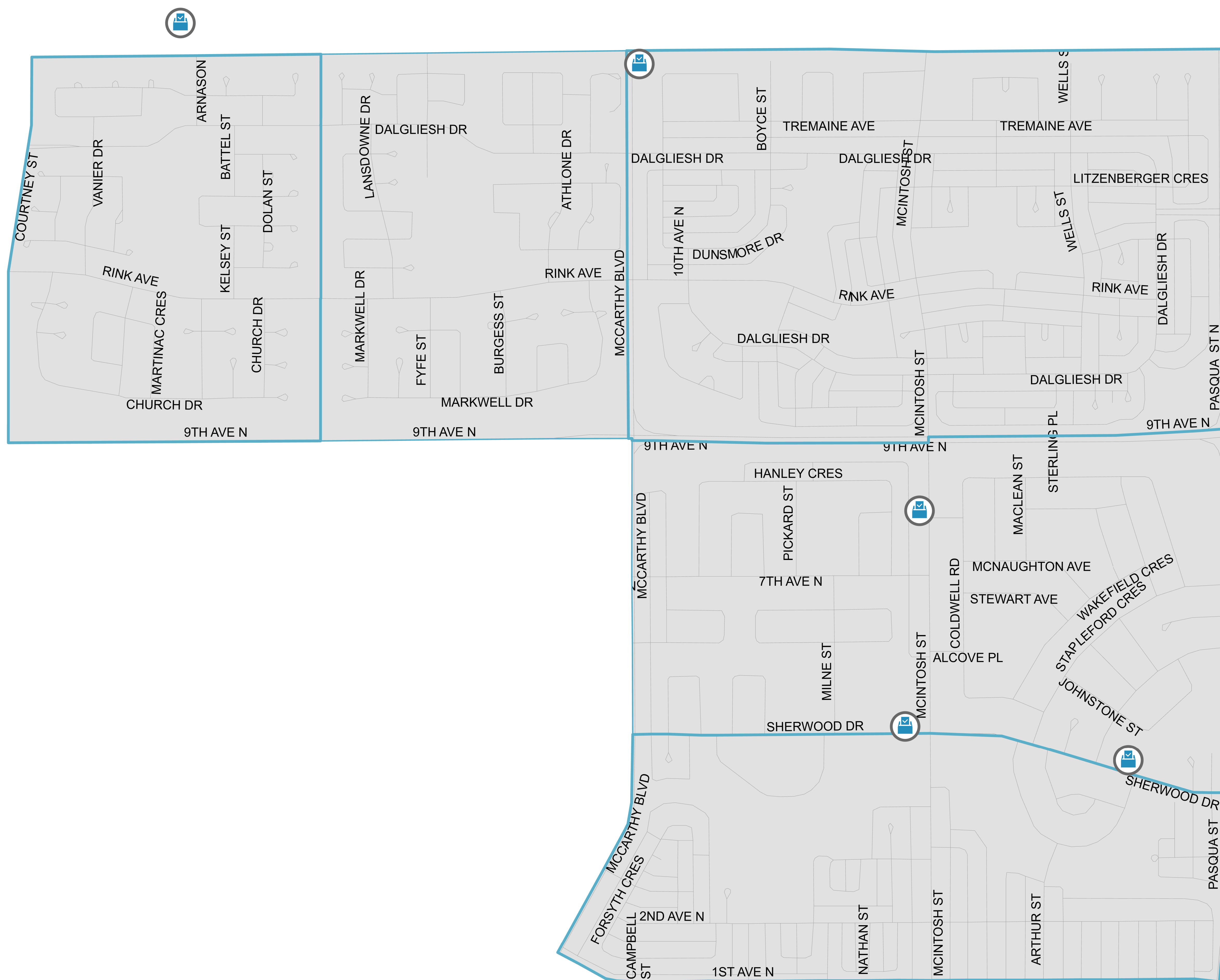
Proclamation of the Returning Officer Declaring the Time and Place for the Nomination of Candidates and the Day of Opening the Polling Places

Proclamation

Constituency of REGINA WALSH ACRES

His Majesty's Writ bearing the date July 13th, 2023, having been directed to me, public notice is now given:

1. That I am commanded to cause an election, to be held according to law, of a member to serve in the Legislative Assembly of Saskatchewan for the above-mentioned constituency.
2. That I will, on July 25th, 2023, from 9:00 a.m. until 2:00 p.m. attend at **145 Dorothy Street, Regina**, to receive nominations.
3. That in case voting of voters is required, polling places will be open from **August 3rd, 4th, 5th, 6th and 8th, 2023 from 12 noon to 8 p.m.** and on **August 10th, 2023, from 9:00 a.m. until 8:00 p.m.**



4. All eligible voters will be able to use the following Voting Week voting locations on **August 3rd, 4th, 5th, 6th and 8th, 2023 from 12 noon to 8 p.m.** and on **August 10th, 2023, from 9:00 a.m. until 8:00 p.m.**, unless otherwise stated:
 - Heritage United Church**, 1050 Arnason Street, Regina
 - Holy Trinity Catholic Church**, 5020 Sherwood Drive, Regina
 - New Hope Lutheran Church**, 370 McIntosh Street North, Regina
 - Prince of Peace Lutheran Church**, 935 McCarthy Boulevard North, Regina
 - St. James United Church**, 4506 Sherwood Drive, Regina
5. That licensed Personal Care Facility voting locations will be established at the following locations during the following times:
 - Arbor Oaks Manor**, 10 Kyle Street, Regina (August 3rd: at 11:00 a.m.)
 - Bethel Manor**, 5161 Sherwood Drive, Regina (August 3rd: at 10:00 a.m.)
 - Cherished Hearts Personal Care Home**, 222 Litzemberger Crescent, Regina (August 4th: at 11:30 a.m.)
 - Dunsmore Villa**, 87 Dunsmore Drive, Regina (August 3rd: at 1:00 p.m.)
 - Kennedy Manor Care Home**, 22 Kennedy Crescent, Regina (August 4th: at 10:00 a.m.)
 - Walsh Acres Manor Ltd.**, 3 Dunsmore Drive, Regina (August 3rd: at 3:00 p.m.)
6. That Hospital and Remand Centre voting locations will be established on **August 10th, 2023, from 9:00 a.m. until 8:00 p.m.** at the following locations during the following hours:
7. That at **145 Dorothy Street, Regina, on August 22nd, 2023 at 9:00 a.m.**, I shall open the ballot boxes and, in the case of a general election, I shall open the ballot envelopes containing the ballots of voters at hospitals and remand centres, count those ballots and, where there are absentee voters and displaced voters, open the ballot envelopes containing the ballots of those voters and count those ballots and make the addition of the votes given for each candidate and declare elected the candidate having the largest number of votes.

All persons are required to take notice and to govern themselves accordingly.
All times in this proclamation are Central Standard Time.

Warning

189(1) No person shall unlawfully take down, cover up, mutilate, deface or alter an election proclamation, notice or other document required to be posted pursuant to this act. Any person violating the provision of subsection 189(1) is guilty of an offence and, subject to subsection 216(2) of this Act, if convicted, is liable to a fine of not more than \$5,000.00 or to imprisonment for a term not exceeding two years or to both.
