
Proclamation of the Returning Officer Declaring the Time and Place for the Nomination of Candidates and the Day of Opening the Polling Place

Proclamation

Constituency of Saskatoon Willowgrove

Her Majesty's Writ bearing the date September 29, 2020, having been directed to me, public notice is now given:

- That I am commanded to cause an election, to be held according to law, of a member to serve in the Legislative Assembly of Saskatchewan for the above-mentioned constituency.
- That I will, on October 10th, 2020, from 9:00 a.m. until 2:00 p.m. attend at **431B Nelson Road, Saskatoon**, to receive nominations.
- That in case voting of voters is required, polling places will be open on October 26, 2020, from 9:00 a.m. until 8:00 p.m. as follows:



4. That in case voting of voters is required, advance polling places for this constituency will be established at the:
- Erindale Alliance Church (Gym - Entrance A East Side), 310 Perehudoff Crescent, Saskatoon** **Saskatoon Wildlife Federation, McOrmand Drive and Range Road 3050, Saskatoon**
Erindale Alliance Church (Fellowship Hall - Entrance C West Side), 310 Perehudoff Crescent, Saskatoon **Willowgrove School (Small Gym) (Daycare Entrance), 805 Stensrud Road, Saskatoon**

on the following days during the following hours:

5. Personal Care Facility polling places will be established on **October 20th to October 24th, 2020**. Please go to www.elections.sk.ca for locations and times.

6. That Hospital and Remand Centre Polls will be established on **October 26th, 2020**. Please go to www.elections.sk.ca for locations and times.

7. That at **431B Nelson Road, Saskatoon**, on November 7th, 2020 at 9:00 a.m., I shall open the ballot boxes and, in the case of a general election, I shall open the ballot envelopes containing the ballots of voters at hospitals and remand centres, count those ballots and, where there are absentee voters and displaced voters, open the ballot envelopes containing the ballots of those voters and count those ballots and make the addition of the votes given for each candidate and declare elected the candidate having the largest number of votes.

All persons are required to take notice and to govern themselves accordingly.

All times in this proclamation are Central Standard Time.

Warning

189(1) No person shall unlawfully take down, cover up, mutilate, deface or alter an election proclamation, notice or other document required to be posted pursuant to this Act. Any person violating the provision of subsection 189(1) is guilty of an offence and, subject to subsection 216(2) of this Act, if convicted, is liable to a fine of not more than \$5,000.00 or to imprisonment for a term not exceeding two years or to both.
